The existing WTP has been rendered obsolete due to the inability of the technology to meet increasingly demanding water quality objectives, in particular the "Forever Chemicals" PFAS, PFOS & PFOA. The requested funding will help pay for the cost of deploying new source water supply, membrane treatment and residuals disposal infrastructure that is required to meet existing and emerging water quality standards. The project will benefit nearly 42,000 customers that includes hospitals, public safety facilities, schools, and commercial/ industrial users.
