4. Project/Program Description

Sunrise Fire Rescue Department responds to emergency calls outside the Sunrise city limits, on multiple regional highways in Broward County (I-595, I-75, Sawgrass Expressway & the Florida Turnpike). There are tens of millions of people that travel through Broward County each year driving vehicles. Many accidents occur on the highways with multiple vehicles, semi-tractor trailers, trailers with fuel or natural gas, vehicle fires, vehicles rolling off high angle embankments, vehicles crashing into waterways, vehicles crashing into marsh/swamp areas, and many other complex emergency incidents. To effectively respond to complex motor vehicle accidents on regional highways, funding is needed to obtain vehicle extrication equipment for eight Sunrise Fire Rescue vehicles. This vehicle extrication equipment will provide for a quick and effective response to life threatening emergencies on highways. Accident patient outcomes can be greatly improved with more effective emergency tools.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

In order to effectively respond to complex motor vehicle accidents on multiple regional highways throughout Broward County, funding is requested to obtain mobile vehicle extrication equipment for eight Sunrise Fire Rescue vehicles stationed throughout the City of Sunrise. This mobile extrication equipment will provide for a quick and effective response for removing vehicles and victims expeditiously in life-threatening emergencies.

b. What activities and services will be provided to meet the intended purpose of these funds?

Sunrise Fire Rescue Department responds to emergency calls outside the Sunrise city limits, on multiple regional highways in Broward County (I-595, I-75, Sawgrass Expressway & the Florida Turnpike). There are tens of millions of people that travel through Broward County each year driving vehicles. Many accidents occur on the highways with multiple vehicles, semi-tractor trailers, trailers with fuel or natural gas, vehicle fires, vehicles rolling off high angle embankments, vehicles crashing into waterways, vehicles crashing into marsh/swamp areas, and many other complex emergency incidents.

c. What direct services will be provided to citizens by the appropriation project?

This vehicle extrication equipment will provide for a quick and effective response to life threatening emergencies on highways. Accident patient outcomes can be greatly improved with a faster emergency response times and more effective emergency tools.

d. Who is the target population served by this project? How many individuals are expected to be served?

Broward County has close to two million residents and there are tens of millions of visitors to the region traveling to and from the Fort Lauderdale International Airport; the cruise and cargo port, Port Everglades; the Amerant Arena (Home of the Florida Panthers National Hockey Team); and the Sawgrass Mills outlet mall. Due to the number of residents and visitors to the area, there are large number of vehicles traveling on the highways and many accidents occur involving multiple vehicles, semi-tractor trailers, trailers carrying fuel or natural gas, vehicle fires, vehicles rolling of high angle embankments, vehicles crashing into waterways, vehicles crashing into marsh/swamp type areas, and many other complex emergency incidents. Although I-595, I-75, Sawgrass Expressway, and the Florida Turnpike are not located within the City of Sunrise, the Sunrise Fire Rescue Department still responds to a significant number of these complex vehicular accidents.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Faster emergency response times and rescue times. Accident patient outcomes can be greatly improved with a faster emergency response times and more effective emergency tools.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The agency will purchase the mobile extrication equipment with the awarded funding or it will not receive the funds.
