a. What specific purpose or goal will be achieved by the funds requested?



This request will be for a state-of-the-art EOC hardened facility to replace a 60 year old re-purposed building. The new EOC will be safe and accessible for public and service personnel. It will be the headquarters for county fire and EMS services, as well as county Emergency Management. The current facility was originally a shop classroom at an old high school. The Florida División of Emergency Management has deemed the current facility as lacking in security and safety to adequately function as an EOC facility during emergency conditions.

b. What activities and services will be provided to meet the intended purpose of these funds?

All county emergency management activities will be located at the facility. Providing a safe, secure central facility will provide necessary emergency activities during hurricanes, fires, and other local emergencies. Additionally, space will be provided for a hardened shelter in the event of inclement weather events. This facility will also provide training and meeting rooms for emergency personnel.

c. What direct services will be provided to citizens by the appropriation project?

All county emergency management activities will be located at the facility (Fire, EMS, and Emergency Management). Also, there will be hardened shelter facilities available for community members to utilize during weather events.

d. Who is the target population served by this project? How many individuals are expected to be served?

Entire population of 15,000 will be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Accessibility and safety of the public and responders during local emergencies. Also, increased efficiency and safety or emergency responders and the public due to updated facilities and training and communication capabilities. This outcome would be seen through the increased efficiency and decreased response time of local emergency services as a result of the new facility, since centrally locating services increases collaboration with regards to response and training.
