### 4. Project/Program Description

The Intensive Early Literacy Acceleration Coaching Pilot Initiative is designed to provide targeted professional development and coaching support to teachers and educational leaders in up to 5 rural school districts to accelerate struggling reader's learning. By providing early literacy educators with intensive coaching support utilizing best practices grounded in the science of reading, this initiative will enhance educators' expertise in identifying early warning signs of struggling readers. This is accomplished by using formative, progress monitoring, and diagnostic data to accelerate K-2 struggling readers' acquisition of foundational reading skills and creates appropriate instructional pathways to proficient reading. This pilot would target alternatively certified teachers, veteran teachers, and teachers with less than five years of experience, many of whom have not received training or course work grounded in the science of reading and need additional support and training.

The ultimate outcome of this pilot will be to equip teachers and leaders with effective strategies to accelerate struggling readers' foundational literacy skills with an emphasis on students performing in the bottom tenth percentile.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Professional learning, professional development and coaching services to early literacy educators and administrators.

#### c. What direct services will be provided to citizens by the appropriation project?

Propel student proficiency with effective program practices to improve instruction. Our professional learning offerings strengthen instructional practice to create engaging, foundational literacy classrooms through in-person or virtual sessions for teachers, instructional coaches, and leaders.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

K-2 early literacy educators, administrators, and struggling readers located in Escambia, Franklin, Gadsden, Hamilton, Jefferson, Lafayette, Liberty, Madison, Suwannee, and Taylor Counties with an expected number of up to 2,500 individuals served.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Enhance the development of early literacy educator knowledge and application of best practices grounded in the science of reading and instruction to accelerate K-2 struggling readers' acquisition of foundational reading skills to become proficient readers. The outcomes will be measured through a multiple measures approach to include formative, progress monitoring, diagnostic, and summative data. In addition, educator and administrator surveys will be collected to ensure goals are being met and ensure the needs of each district/school are tailored to their student population.

Reversion of funding to the state.
