To connect at-risk youth to educational and career opportunities and skill-building initiatives that enhance their abilities to achieve economic prosperity through the City's reconnection program.

b. What activities and services will be provided to meet the intended purpose of these funds?

Educational, vocational, post-secondary and job opportunities for participants in TEMPO. Specifically, the program provides for the reengagement of Opportunity Youth through implementation of the seven phases of case management, GEDs through local adult and community education providers, workforce training programs at local educational and technical centers, and apprenticeships and pre-apprenticeships with local business partners.

c. What direct services will be provided to citizens by the appropriation project?

Participants will receive direct case management and access to career and educational opportunities. The broader public will see improvements to the community's economic development, public safety, quality of life, and impact on poverty.

d. Who is the target population served by this project? How many individuals are expected to be served?

Participants will achieve greater educational and employment opportunities than they would if not for the program. The City regularly assesses the success of TEMPO by measuring the number of participants, GED completions, college enrollment, and job wages.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Future appropriations would be under greater scrutiny if the City failed to deliver on its contractual obligations.
