#### 14. Program Performance



#### a. What specific purpose or goal will be achieved by the funds requested?

The Tallahassee-Leon Council on the Status of Men and Boys (CSMB) was established as a local collaboration to study and address local gun violence. Using federal grant funds awarded to CSMB, Florida State University conducted research into problem causes and recommended solutions. FSU rendered a report recommending evidence-based interventions outside CSMB's scope and LCSO's present capacity. Funds will be used to establish an LCSO Gun Violence reduction Unit (GVRU) comprised of one full-time sergeant, two full-time deputy/detective positions, and one fulltime Intelligence Analyst.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Services provided will include, but not be limited to, focused deterrence, coordination of gun crime reviews with appropriate parties including federal and state prosecutors, task force development and participation, and referral services.

#### c. What direct services will be provided to citizens by the appropriation project?

Direct services to citizens would include, but not be limited to, focused deterrence, delivery of social services and support, increased monitoring of high-risk individuals, follow-up communication and resource support, and referral services.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

From June 4, 2019 - June 4, 2023, Leon County experienced 733 homicides and non-fatal shootings. Gun violence impacted a total of 1,255 victims in Leon County during the study period, most frequently black males in their mid to late twenties. Focused deterrence, delivery of social services and support, increased monitoring of high-risk individuals, follow-up communication and resource support, and referral services would directly benefit both the at-risk population and the entire resident and visitor population of Tallahassee/Leon County which exceeds 300,000 persons.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This unit will operationalize the evidence-based gun violence interventions recommended in the FSU report. Success will be measured by the future reduction in gun violence incidents as compared to the existing baseline.
