Create 15 STEM lab classrooms that will serve A.S. degree programs including Network and Computer Systems Administration, Cybersecurity, and Artificial Intelligence. These programs must be taught in a secure and technologically advanced environment in order to provide the best preparation for the workforce.

b. What activities and services will be provided to meet the intended purpose of these funds?

Remodel existing building on the TCC main campus to convert 29,838 sf into 15 STEM classroom labs. The project budget includes planning, architectural and engineering services, required permits and inspections and construction. The construction project includes a reconfiguration of space, HVAC ductwork, electrical, upgrade air handlers, installation of AV equipment, technology, and furniture.

c. What direct services will be provided to citizens by the appropriation project?

These programs will provide employment opportunities for students in high-wage and high-demand fields. It will provide immediate economic impact to our students as well as meet regional hiring demands in these fields.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population are students and future students in the Network and Computer Systems Administration, Cybersecurity, and Artificial Intelligence AS degree program at TCC. This 2-year program provides a great opportunity to obtain valuable skills and credentials for high-demand, high-wage jobs. This will provide economic mobility and financial stability for participants.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Provide robust A.S. degree programs; an increase in the number of students earning an AS degree as measured by participants and successful completions. This initiative will also provide employment opportunities and economic mobility as measured by job placements.
