This project will include the milling and resurfacing of C 466 between Buena Vista Boulevard and Morse Boulevard and installation of thermoplastic roadway stripe. The roadway lies within the heart of the largest age-restricted development in the world with disadvantaged citizens in surrounding areas that are low income and burdened with housing, health, and climate change. This roadway has a pavement condition index ranging at and below 40 and an average daily traffic of over 23,000 vehicles per day. Due to these conditions, Sumter County has deemed this project a high priority.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The purpose of the requested funds is to improve the poor conditions of a roadway that lies within the heart of the largest age-restricted development in the world with disadvantaged citizens in surrounding areas that are low income and burdened with housing, health, and climate change. This roadway has a pavement condition index ranging at and below 40 and an average daily traffic of over 23,000 vehicles per day. Due to these conditions, Sumter County has deemed this project a high priority.

b. What activities and services will be provided to meet the intended purpose of these funds?

To meet the intended purpose of these funds, the contractor will mill and resurface the roadway, as well as install thermoplastic roadway striping. This will significantly improve the pavement condition index (PCI) of the roadway by providing a smoother and improved riding experience for the high volume of travelers of the roadway.

c. What direct services will be provided to citizens by the appropriation project?

The direct services to be provided to citizens by the funding requested include giving the high number of roadway travelers, which include citizens in the largest age-restricted development in the world as well as disadvantaged citizens in surrounding areas, an improved roadway to travel on. This roadway will provide a smoother and enhanced riding experience without the adverse effects of irregularities in the roadway like deformations and cracking.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project will be the residents of the largest age-restricted development in the world that the roadway runs through, as well as disadvantaged citizens in surrounding areas in tract numbers 12119910100, 12069030411, and 12069030407 that are considered low income and burdened with housing, health, and climate change according to the Climate and Economic Justice Screening Tool. There are thousands of individuals that are expected to be served as the roadway has an average daily traffic of over 23,000 vehicles per day.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

An expected benefit from this project includes improved transportation conditions. Milling and resurfacing the roadway will provide a smoother and improved riding quality for travelers. The level of benefit can be measured by tracking the improved Pavement Condition Index (PCI) of the roadway. Another expected benefit from this project is an increase in economic activity. More people are likely to travel the roadway if it is in better condition. There is a correlation between traffic volumes on a roadway and economic activity. The level of benefit can be measured by tracking the Average Daily Traffic (ADT) of the roadway.
