The majority of funds will benefit no specific group.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Reducing flooding in roadways will result in less standing water filled with contaminants on roadways. During flood events, residents often interact with flood waters to leave their homes or travel within the Village, exposing them to these contaminants. This will be measured based on the total number of days the area is flooded over 6 inches per year. Flooding is an environmental threat to public safety and health. Reducing flooding will keep residents out of vulnerably situations, particularly children, the elderly, and those with different abilities. Reducing flooding on roadways during rain events ensures the transportation network in the Village is able to continue to function. The project will also involve raising roadways which will improve transportation conditions during rain events. Measuring this level of benefit or outcome will be based on the number of streets flooded during heavy rain events.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Failure to meet deliverables without notification will result in financial penalties as described in the contract.
