c. What direct services will be provided to citizens by the appropriation project?

The Mitzvah Kitchen provides the only community-run, industrial kosher kitchen in Miami-Dade area that engages individuals with special needs and volunteers from various businesses who prepare and distribute restaurant-quality meals to individuals and families (Jewish and non-Jewish) experiencing food insecurity as it relates to kosher restrictions.

d. Who is the target population served by this project? How many individuals are expected to be served?

Children with disabilities, the religious jewish community and community at large.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Working in a kosher kitchen within a Jewish community center offers cultural enrichment, promoting tolerance and diversity, while enhancing culinary skills and understanding. Outcomes will be assessed through community involvement, peer and community feedback, participant reflection surveys, and cultural tolerance surveys.
