4. Project/Program Description

Kimberly's Center is both the Children's Advocacy Center and Child Protection Team in Marion County. This private, nonprofit organization has seen exceptional growth in the past 5 years and needs additional space. The organization has added two new major programs and initiated a co-location model with local Department of Children and Families staff as well as local law enforcement. Funds will be used to add more than 4,500 sq. ft. to the existing Kimberly's Center facility and renovate an existing 1,000 sq. ft. of the facility. This building addition and renovation will impact the children and families who are facing the trauma of abuse by providing appropriate, safe, child-friendly, dedicated space to receive critical intervention services and facilitating their recovery process. Additionally, it will provide community partners in local law enforcement, and the Department of Children and Families with the space they need to further investigate allegations.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funds will be used to add more than 4,500 sq ft to the existing Kimberly's Center facility and renovate an existing 1,000 sq ft portion of the facility. This additional space will include the construction of a new child friendly and safe lobby and waiting room area, that will provide adequate waiting space with social distancing. Additional space will also allow for continued program expansion to serve children and teenagers impacted by abuse and neglect. Space will also include dedicated offices for local law enforcement and the local Department of Children and Families staff to be able to meet privately with families engaged in the child welfare system.

b. What activities and services will be provided to meet the intended purpose of these funds?

Kimberly's Center is already engaged in the process of working with local County officials in the spending down of awarded DEO and CDBG-CV dollars on this construction project. The local public bid process has been completed and the contract has been awarded to a local construction company that is ready to break ground by the end of this calendar year. The board and staff are continuing to work with local donors, businesses, financial institutions to raise the needed \$820,000 to complete this critical project.

c. What direct services will be provided to citizens by the appropriation project?

Kimberly's Center for Child Protection will provide critical child abuse prevention, investigation, and treatment services to children throughout Marion County with the additional space provided in this project. Kimberly's Center will provide forensic interviews, specialized interview, medical examinations & consultations, prevention education, trauma therapy, and advocacy services to child abuse victims and their families. Additionally, education services are provided throughout the county to adults and children to educate and prevent child abuse.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population of this project are children and families impacted by allegations of child abuse and neglect. Annually, Kimberly's Center serves more than 1,300 children with investigative and treatment services. Staff of Kimberly's Center are also partners with the Marion County Public Schools and go into classrooms throughout the County to teach the Child/Teen Safety Matters Curriculum to thousands of students each year.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

This project will allow for the continued growth of programs and services for children and teenagers in Marion County who have been impacted by allegations of child abuse and neglect. All services provided at Kimberly's Center are tracked and reported annually to multiple state and local funders. The mission of Kimberly's Center is to reduce trauma to children during the investigations process in order to mitigate some of the long term effects of adverse childhood experiences.
