#### 4. Project/Program Description

Programming, preliminary design and development of a funding strategy for a new Mental Health Housing Pod at the Martin County jail to house between 200 to 400 inmates with mental health issues. The new facility will provide direct services to the inmate population by implementing the Mental Health Step Down Program and court ordered release programs (Transitional Release Programs). The Mental Health Step Down program is a unit-based, residential program offering an intermediate level of care for inmates with serious mental illnesses who do not require inpatient treatment but lack the skills to function in the general population.

MC received \$31,272,363 from the American Rescue Plan Act (ARPA) which is currently being utilized to provide grants to community partners and fund capital infrastructure for clean water.

a. What specific purpose or goal will be achieved by the funds requested?



The specific goal the Martin County Sheriff's Office will be able to implement with this project includes the Mental Health Step Down Program for incarcerated inmates and court ordered release programs (Transitional Release Programs).

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The Martin County Board of County Commissioners and the Martin County Sheriff's Office will engage a team of architectural design consultants that specialize in the space programing, planning, construction funding and construction of a correctional facility housing pod that incorporates mental health services. The focus of the programming and design will be provide various degrees of mental health services to the inmate population and support the MCSO's Mental Health Step Down Program.

#### c. What direct services will be provided to citizens by the appropriation project?

The direct services provided to the inmates in the future Mental Health Housing Pod include application of a Mental Health Step Down Program for incarcerated inmates and court ordered release programs (Transitional Release Programs). A step-down program will assist in the positive upward progression of an inmate. In addition, mental health court can provide parameters and conditional releases to monitor the inmates when they leave the facility. Untreated mental health issues and crises lead to criminality. Once the mentally ill become stable under treatments provided in the proposed Mental Health Housing Pod, crime will reduce.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The proposed Mental Health Housing Pod is anticipated to house between 200 and 400 inmates. The Martin County Sheriff's Office engaged a consultant to perform a Needs Analysis to better define the size of and general programming of the proposed pod.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

A step-down program will assist in the positive upward progression of an inmate. In addition, mental health court can provide parameters and conditional releases to monitor the inmates when they leave the facility. Medication, positive programs, counseling, integration into the community and building positive relations with family members.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

For this multi-year funding project, if the project fails to be completed or fully funded, the unused, uncommitted portion of the funding will be returned to the State.
