4. Project/Program Description

Currently, municipal utility service is lacking along a portion of US 1 heading into Ormond Beach. This area is part of the underserved area of Flagler County and will provide service to current and future businesses and residential homes and communities and will help the environment by moving them from septic to sewer working in partnership between the Florida Governmental Utility Authority (FGUA), a special purpose government and Flagler County. FGUA operates the water and wastewater plant in this area of the county and has indicated there would be needed improvements to the plant and further connections installed to allow for extra capacity. It will also encourage new commercial and residential growth along the US 1 corridor in Flagler County, which will help to diversify the tax base and reduce the tax burden to residents and allow for more affordable or workforce housing.

a. What specific purpose or goal will be achieved by the funds requested?



To allow for extra capacity and new connections to move current businesses and home communities from septic to sewer and provide connections to water. It will also encourage new commercial and residential growth along the US 1 corridor in Flagler County, which will help to diversify the tax base and reduce the tax burden to residents and allow for more affordable or workforce housing.

b. What activities and services will be provided to meet the intended purpose of these funds?

FGUA will make improvements to the current plant and bring connections along the US 1 corridor that is currently unserved. These improvements will provide service to current and future businesses and residential homes. It will also help the environment by lowering nitrogen and phosphorus levels and improve water quality to the area.

c. What direct services will be provided to citizens by the appropriation project?

The project will provide an opportunity to the residents and local businesses to eliminate the need to use septic systems for disposal of domestic sanitary sewer by connecting to a central sewer collection system and provide improvements to the water quality in that area. It will also open the door for new businesses and workforce housing opportunities along the US 1 corridor.

d. Who is the target population served by this project? How many individuals are expected to be served?

There are currently 44 dwellings in the area that will benefit immediately through access to sewer and water and a number of small businesses as well. The real target population is the future home communities, commercial and industrial development that will take place along this corridor. This project will result in several affordable housing communities being established providing homes to our current and future residents as well as new business and light industrial development to help diversify the tax base.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Once the project is complete there are both commercial and industrial opportunities along the US 1 corridor which will bring job opportunities to the area and specifically for those working in the affordable housing communities built as a result of these improvements. This will be measured through the number of jobs created as a result of increased businesses in the area.

The project will also improve water quality and reduce Determining the reduction in current and future septic systems and the known nutrient load per system provides a means to measure the success of the central sewer system.

Standard contract penalties are sufficient.
