4. Project/Program Description

Funds will provide for the complete renovation of Child Guidance Center's 13 bathrooms, 4 kitchenettes, janitor's closet (with drain and running water) and several non-functioning water fountains in the 3 Child Guidance Center's mental health outpatient clinics. Interior plumbing at all 3 physical sites is outdated and functions on an inconsistent basis. Old grout and tile, as well as old sinks and toilets, create issues with cleaning and sanitizing in all spaces with interior plumbing. Poor ventilation in restrooms is an issue.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The over 4000 children plus their family members (>10,000 clients) served annually through our Outpatient Program are affected by the condition of our 13 bathrooms in 3 physical sites, which have fallen into disrepair and are no longer capable of being fully sanitized nor operate consistently. Old floor tile and grout, wall tile, cracked counters, chipped toilets/urinals, scratched faucets and mirrors, old lighting and wiring, as well as poor ventilation including old AC ducts need to be replaced.



b. What activities and services will be provided to meet the intended purpose of these funds?

Funds are requested for the provision of safe and sanitary restrooms (as stated above) for the over 4000 children and their family members seeking mental health services. Kitchens used for staff meal preparation are no longer in good working order. The Janitor's closet, which has running water and a drain, is no longer capable of being used. Our public water fountains are no longer functional.

c. What direct services will be provided to citizens by the appropriation project?

Direct Services will not be provided to clients with this funding which is for the repair and upgrading of interior plumbing concerns throughout our 3 agency owned facilities.

d. Who is the target population served by this project? How many individuals are expected to be served?

The population served is the over 4000 children and their family members (>10.00 clients) who seek mental health services from CGC, plus the over 120 staff employed by our agency. Safe and sanitary restroom facilities are not only necessary but respectful to provide. Staff deserve operational restrooms and kitchen facilities for their 8-10 hours onsite.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Consistent, convenient and respectful provision of mental health services which requires operational bathrooms. Sanitary kitchen spaces necessary for mental health staff to easily access lunches and dinners. Sites have had to close when toilets are nonfunctional. Staff and clients have at times had to leave the clinics to use other bathroom facilities. Mental health services for children and families will continue to be provided on a consistent basis and in a sanitary and respectful manner. Treatment encourages a decrease in: mental illness, physical and sexual abuse, domestic violence, behavioral issues at school, thereby encouraging increased educational success, increased ability for successful future and decreased criminal activity.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If the monies are not used, funding will be returned to the State.
