Provide improved access to water distribution system for construction projects, emergency breaks and emergency/disaster mitigation by providing greater access to the system.

b. What activities and services will be provided to meet the intended purpose of these funds?



The town will contract to place valve can extenders around existing distribution system valves and place concrete collars around to provide improved ability to quickly locate existing valves. We will also be placing insertion valves throughout the system in areas without adequate valves to provide the necessary access to the system.

c. What direct services will be provided to citizens by the appropriation project?

Residents will benefit by having few service interruptions. This project will provide greater reliability in the system with few properties impacted by any need to temporarily discontinue service for repairs.

d. Who is the target population served by this project? How many individuals are expected to be served?

The entire community of 1,830 residents will be served by this project.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Decrease possible road closures, limit disruptions to public safety access, Enhance the water distribution system, reduce water loss, increase access and reduce the amount of time and the number of properties impacted by line breaks or line leaks. We will measure the benefit of the project by collecting data on the number of residents impacted by service interruptions and the amount of time necessary to complete repairs before and after the project.

A corrective action plan will be put in place until deliverables are met.
