14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Upgrade the East Putnam Regional Waste Water Treatment Plant by constructing additional ribs, installing two 150,000 gallon treatment towers, and emplacing the required connecting tubing. This would increase the plant's capability by 300,000 gallons of effluent water daily, meaning the plant could expand its current capacity of serving 1,200 households to a total of 2,700 households. Our current treatment facility can handle the expansion which would service customers along SR 207 and CR 207-A permitting those residents in proximity of the St Johns River to switch from sewer to septic.

b. What activities and services will be provided to meet the intended purpose of these funds?

Expansion of water treatment/sewer service in East Palatka area, notably in residential neighborhoods adjacent to the St Johns River where FDEP has identified concerns with continued use of septic systems. This expansion will allow the waste water treatment plant to service 2,700 households compared to the current 1,200 capacity.

c. What direct services will be provided to citizens by the appropriation project?

Sewage service to residential homes along SR 207 and CR 207-D corridors.

d. Who is the target population served by this project? How many individuals are expected to be served?

All citizens of East Palatka

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Residents will be able to switch from septic to sewer which will result in less possibility of contamination of ground water, aquifer and the environment.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Standard contract penalties are sufficient.
