a. What specific purpose or goal will be achieved by the funds requested?

The goals of this Project are to defend the innocence and dignity of Florida's children by: advancing sound public policies; promoting public awareness; implementing trainings, leveraging public-private partnerships; engaging Florida leaders and stakeholders, and empowering law enforcement to prevent the growing pandemic of the online exploitation of children and to establish Florida as a safer Internet model state.

b. What activities and services will be provided to meet the intended purpose of these funds?

EIE intends to deliver four items: an expanded Internet Safety 101 Academy digital curriculum, marketing/PR efforts to raise public awareness, a train-the-trainer program and establish a statewide Internet Safety Advisory Council. This will create Internet safety digital and in-person trainings/train-the-trainer events, Internet Safety 101 Academy, marketing and public awareness campaigns, and the creation of an Internet Safety Council.

c. What direct services will be provided to citizens by the appropriation project?

The Project programs and campaigns will educate, equip and empower parents, grandparents, caregivers, educators, community leaders, law makers and law makers and law enforcement to prevent online exploitation of children from pornography, sexual predators/traffickers, cyberbullying, sextortion and risks associated with gaming and social media platforms.

d. Who is the target population served by this project? How many individuals are expected to be served?

Parents, grandparents, caregivers, educators, community leaders, law makers and law enforcement. Over 800 individuals are expected to be served.
