Feed Unite Flourish will serve over 250,000 food insecure people across Indian River, Martin, St. Lucie and Okeechobee Counties. Infrastructure Expansion: build a 132,000 sq. foot purpose-designed warehouse facility to meet needs of low-income, food insecure families including Florida's 6th largest city. Designed to meet projected 76% increase in food and disaster relief. Workforce Development: Put the Treasure Coast back to work through creation of jobs by capital project and wraparound program service expansion.

#### 14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



To serve the 250,000 food insecure people across the Treasure Coast service area, Treasure Coast Food Bank has embarked on a capital effort to build a phase one 132,000 sq. foot purpose designed facility that will meet the projected demand for food relief and disaster preparedness/meal production while also housing wraparound services, such as health screening, nutrition education, financial literacy, job training and more. As a result, food distribution capacity will be increased by 76%.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The facility will not only meet the projected demand for food relief and disaster preparedness across 4 counties while supporting 300 partners, but also provide wraparound services including health screening, nutrition education, financial literacy, job training, additional capacity for deployment for social enterprise programs and more.

#### c. What direct services will be provided to citizens by the appropriation project?

In addition to serving 28 million meals annually, the facility will have 20,000 sq. feet set aside for our job training center and community partner program services, a community room with public meeting space available to local non-profits, businesses, and organizations, and increase capacity for disaster preparedness and emergency response.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Elderly persons, persons with poor mental health, persons with poor physical health, jobless persons, economically disadvantaged persons, at-risk youth, homeless, developmentally disabled, physically disabled, preschool students, grade school students, high school students, university/college students and small business entrepreneurs. The program will serve over 250,000 annually.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Offering 28 million meals per year, 80% of which are considered foods to encourage that lead directly to better community health. Medical screenings and prescription meals, through partnerships with health care organizations for medically at-risk individuals and senior citizens, will improve physical health based on our work with the Food is Medicine Coalition Accelerator Program. Track the number of people provided health screenings and healthy meals as well as outcomes related to interventions. Create household income through job training and ancillary services, returning 275-450 people to the workforce every year. Track the number of job training program participants trained and employed. The facility's centralized social services partnership model and our case management services build individual and family capacity by providing access to important benefits and connecting people to resources and opportunities that enable self-sufficiency. Track number of users at local facility.
