Emergency response by boat to incidents in areas that cannot be serviced quickly in emergencies with current equipment. For example, the Rib Boat/Hard bottom boat is capable of traversing the deeper locations on Lake Okeechobee. The Airboat(s) is capable of crossing the swamp and shallow parts of lake, but is not capable of covering the larger open water areas of the lake in adverse conditions.

Palm Beach County Fire Rescue will be able to drastically improve the available resources, provide for the safety of our personnel as well as the timeliness of responding to emergency calls on Lake Okeechobee.
