c. What direct services will be provided to citizens by the appropriation project?

Increase access to Youth Programs within the community and increased access to food security for vulnerable seniors through the increased delivery of meals to more of those seniors who are in need in our community.

d. Who is the target population served by this project? How many individuals are expected to be served?

This project will target around 400 of the community's elders, homeless, at-risk youths, persons with poor mental and physical health, economically disadvantaged persons, developmentally and physically disabled, students, the formerly incarcerated and victims of crime.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Keeping children and young youth away from unsafe, crime driven, or dangerous situations they would encounter after school unattended leads to safer communities. Furthermore, It will benefit the mental health of the overall community: The children will be taken care off and unsupervised; not left to their own devices which will remove causes of stress, anxiety and depression. The parent of these children will also feel a form of stress and mental relief knowing their children are well taken care off. Lastly, the elders will have food security and not be worried about food insecurity.
