Direct services to citizens is a local Emergency Operations Center for police, public works and the general services department that will address over flow needs for County 1st Responders from which to provide efficient public safety services in order to protect life, health, safety and property of citizenry, residents, visitors and the business community; reduced insurance costs and less damage to property in this financially disadvantage municipality located in a Rural Area of Opportunity.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target population is the community of Okeechobee, which is a Financial Disadvantaged Municipality (ch. 62-552, F.A.C.) located in a Rural Area of Critical Economic Concern/Rural Area of Opportunity (s. 288.0656, Florida Statutes); Greater than 5,000 to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Expected benefit is to protect general public from harm with substantially hardened public services facility that will serve as an additional Emergency Operations Center for police, public works and the general services department and will address over flow needs for County 1st Responders. Completion of the resiliency hardening improvements and certification of the project.
