4. Project/Program Description

The study for the Creek will be conducted in 2023-2024 in partnership with Pinellas County and the City of Clearwater. It is currently budgeted at \$78k. The purpose is to understand the environmental impact to surrounding areas, including runoff, and how downstream silting ultimately affects the inland waterway. Restoration and renovation of the creek, is expected to cost between \$200k and \$500k if completed in fiscal year 2024-25. The expected scope of work for this project would include reinforcing the bank of the creek, rehabilitation of areas with high flood risk, and future mitigation of vegetation build-up.

a. What specific purpose or goal will be achieved by the funds requested?

To prevent degradation of the creek bank as well as accumulation of silt and sediment in Harold's Lake. This will secure the banks and houses along the creek and prevent overflow of the Lake during rain events.

b. What activities and services will be provided to meet the intended purpose of these funds?



This project calls for a study to be completed in 2023-2024, which will clarify the environmental impacts to the surrounding areas, including runoff, and how downstream silting ultimately affects the inland waterway. Restoration and renovation of the creek will include reinforcing of the bank, rehabilitation areas with high flood risk, and future mitigation of vegetation and sediment build up.

c. What direct services will be provided to citizens by the appropriation project?

By completing this project, residents and tourists will use the area for recreation, it can enrich cultural experiences by presenting an ideal venue for artists and photographers, and protect the general public by preventing flooding during storms and mitigating bank erosion.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population are the residents of Belleair. Estimated 4,000 residents. Tourists in the surrounding area will also be impacted.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Drainage conditions will be greatly enhanced by reinforcing banks and maintaining vegetation. Flooding will be mitigated greatly as well. This improvement will be measured through inspections prior to the renovation and restoration, then compared with data collected after the project. Restored areas will attract more wildlife, which will be measured by interested citizen groups to annually survey the area for increases in natural activity and report to the Town, which will be relayed to the Department of Natural Resources. A restored creek and lake will attract more residents and tourists, which will be measured by frequent counts of the individuals using the area

The applicant, Town of Belleair, FL, will be barred from applying for further state funding for this project for the duration of the project. Unspent allocations will be returned under a negotiated agreement.
