#### 4. Project/Program Description

This project's purpose is to construct a new +/- 7,000 square feet hardened shelter/ multi-purpose building and enclose the existing +/- 200 feet x 300 feet Hurricane Staging arena. It also includes a stormwater retention area. During Hurricane Idalia, there was a lack of space for the deployed, outside emergency personnel, who inundated the nearby county emergency operations center. This caused issues with meeting and coordinating efforts during this declared emergency. The new structures will provide space for outside emergency personnel, who are activated during disasters, to convene. The new structures will be built to enhance resiliency against damage from hurricanes and other severe storms. The covered arena will also give the county much more opportunity to host rodeo and many more outdoor events for the community and surrounding counties.

#### 14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The county was devastated by the most recent hurricane Idalia and as a result, the county required an ample amount of assistance from outside agencies. This project's purpose is to construct a new +/- 7,000 square feet hardened multipurpose building, enclose the existing +/- 200 feet x 300 feet Hurricane Staging arena. and construct storm water retention area for the improvements. These improvements would give the county a location where resources could be staged after a catastrophic event such as hurricane Idalia.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

After hurricane Idalia brought destruction throughout the county, numerous outside resources came to the aid of the county. The new buildings will provide space for outside emergency personnel, who are activated during disasters, to convene and help aid the citizens. The covered arena would also give the county much more opportunity to host rodeos and other outdoor events for the community and surrounding counties.

#### c. What direct services will be provided to citizens by the appropriation project?

A dedicated staging location for outside resources who have donated needed necessities for citizens during a state of emergency such as hurricane Idalia. This location would also offer multiple community events for the citizens such as rodeos.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for the hosting of events is the community of Dixie County and surrounding areas; Dixie County's population is +/- 17,000. The target population for the outside emergency personnel will vary depending on the length, severity and duration of the emergency situation.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Currently, the rodeo arena is a wide-open space that is not protected against inclement weather, nor the hot summer sun. The benefit of the newly enclosed space is to provide protection for those participating and those watching the rodeo activities. The benefit of these structures during disasters is to provide needed space for emergency personnel to convene and plan the necessary activities to remedy the issues that the community incurs due to unforeseen circumstances.
