Replace seawalls at three City locations to make the areas stronger and more resilient to ultimatley reduce the flooding waters from the bay during very high tides and storms. Three locations: (1) 141st Ave Stormwater Pump Station-will help protect the stormwater pump; (2) 133rd Ave at Boca Ciega St end-will help reduce flooding impacts to streets and adjacent properties/homes; and (3) City Marina - strengthen Marina site to also reduce/alleviate future flooding.
