### 4. Project/Program Description

Zoo Miami's Sea Turtle Rescue/Rehab Center serves a critical need for the rehabilitation of sea turtles. It provides a central location in Miami-Dade County for receiving injured or sick sea turtles. Within the past year, three sea turtle centers serving South Florida have lost the ability to house new or long-term patients. The redistribution of their turtles and the increased number of new patients has placed added pressure on the facilities at Zoo Miami. An expansion of infrastructure and addition of required equipment would allow Zoo Miami to greatly increase the ability to provide urgent medical care and appropriate rehabilitation of these animals. This expansion would allow Zoo Miami's Sea Turtle Rescue/Rehab Center to increase carrying capacity, while improving the life support systems, a critical component to the recovery and health of sick and injured turtles.

a. What specific purpose or goal will be achieved by the funds requested?



The funds would support the design/construction for the expansion of Zoo Miami's Sea Turtle Rescue/Rehab Center, a central location in Miami-Dade County for receiving injured or sick sea turtles. An expansion of infrastructure would allow Zoo Miami to greatly increase the ability to provide urgent medical care and appropriate rehabilitation, while improving the life support systems, a critical component to the recovery and health of injured sea turtles.

### b. What activities and services will be provided to meet the intended purpose of these funds?

Expansion of the Zoo's Sea Turtle Rescue/Rehab Center would greatly increase the ability of Zoo Miami Veterinarian staff to provide urgent medical care and rehabilitation services. These services include medical examination and treatment for turtles effected by boat strikes, fishing hook entanglements, and other injuries or diseases.

### c. What direct services will be provided to citizens by the appropriation project?

Zoo Miami will be able to expand service as a health care resource in the South Florida region for endangered native sea turtles, critical to the conservation and preservation of the environment. As three sea turtle centers serving the region have recently lost the ability to house new or long-term patients, the redistribution of turtles and the increased number of new patients is in high demand.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

General public in South Florida region - residents and annual attendance of over 1 million visitors.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

Treatment, recovery and rehabilitation of numerous sea turtle species in South Florida. The methodology for measuring outcomes will include Sea Turtle Rescue/Rehab Center intake records, the # of sea turtle releases, and recorded contacts with FWC, USFWS and other organizations.

Expansion will also allow greater opportunities to educate the community on Zoo Miami's conservation efforts to help wildlife found locally in Florida. Opportunities include programming with on-site students from the Miami-Dade County Public Schools BioTech Magnet School.
