Installations will convey the role of FWC in connecting lands and waters supporting wildlife and people, augmented by educational programs delivered through MODS' EcoExplorers workforce development internship. The project supports Florida's Resilience Action Plan.

### b. What activities and services will be provided to meet the intended purpose of these funds?

MODS will partner with the FWC Foundation and 2 Broward organizations to develop 3 installations that raise awareness of FWC by focusing on the wildlife best represented by each partner - coastal, urban and Everglades. 80 underserved high school youth will provide ancillary environmental programs through a year-long paid workforce development internship that supports pursuit of resilience careers.

### c. What direct services will be provided to citizens by the appropriation project?

The project raises awareness of and galvanize support for the Corridor and its impact on the state's ecology and economy. It empowers the public to take personal action, broadens civic engagement and education in resilience issues, inspires and trains youth to pursue the demand for resilience jobs and develops a better skilled workforce that results in a more sustainable and prosperous Florida.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The funds requested will serve the following target populations: economically disadvantaged persons; at-risk youth; preschool students; grade school students; high school students; and university/college students. The workforce development internship will impact 80 underserved high school youth with workforce training, paid employment, uniforms, field study expenses and transportation. Together, the workforce development and capital project will annually impact 1 million Florida residents from at least 76% of Florida counties and tourists from all 50 U.S. states and 20 foreign countries at 3 Broward locations.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

State funds will advance Fla Wildlife Corridor goals through three permanent installations at MODS and two other Broward locations impacting 1 million annually from at least 76% of Florida's counties. Funds also provide workforce training, paid employment, uniforms, field study expenses and transportation for 80 underserved high school youth to develop and deliver ancillary public programs to support the installation. The outcome, measured through FWC feedback and surveys of the public, will result in a higher degree of pro-environment behavior to support the goals of the Florida Wildlife Corridor.

### f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

### for failing to meet deliverables or performance measures provided for the contract?

Funding will be withheld for failing to (1) Fabricate and install 3 installations at MODS and 2 other Broward locations (2) Highlight the vital role the Florida Wildlife Corridor (FWC) plays to protect the state's lands and waters in support of wildlife and people (3) Implement paid workforce development training to augment FWC installation through environmental programs conducted by MODS' EcoExplorer interns and (4) Impact 1 million Florida residents and tourists annually at all 3 locations.
