14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The Arc Nassau has been in their primary location since the early 80's. In that time, minimal renovations and upgrades have been completed to this aging facility. b. What activities and services will be provided to meet the intended purpose of these funds?

The Arc Nassau provides programs and services for adults with intellectual and developmental disabilities. Programs for Life Skills Development, Employment Services, 2 major contracts providing janitorial services through RESPECT of Florida/FDOT, and a small thrift store that generates revenue for inhouse programs. The grounds at this location provide community recreation as well.

c. What direct services will be provided to citizens by the appropriation project?

Funding would directly impact major renovations to the building that provides vital programming and support for people with varying abilities. By bringing the building up to code, it will ensure programming for future generations as Nassau county continues to experience an increase in population. Renovations would make it possible to expand programming to other age demographics.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served are elderly persons, people with poor mental health, people with poor physical health, the unemployed, physically disabled persons, and developmentally disabled persons. We expect 51-100 in the target population to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Improved physical health as it would be physically and mentally engaging to have a variety of equipment and space to explore daily, which would be measured by the amount of participation, acquiring of new skills and strength via daily scheduled activities. Improved mental health through daily outdoor physical activity would be measured via trainers who will measure participation and give daily reports. Quality of education provided to clients is tracked already through attendance and daily, monthly, and quarterly goals and outcomes, and participation in physical activities will increase physical health. For specific individuals, their economic self sufficiency would be impacted as renovations would make our location more visible and viable to the public and generate more leads for our Employment Services agency. The Arc Nassau has been working in tandem from referrals through Vocational Rehabilitation for several years, the amount of referrals received would be our way of measurement.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Funding would be returned immediately if funds appropriated do not meet the deliverables or performance measures.
