### 4. Project/Program Description

22ZERO is a nonprofit, incorporated in Florida, serving the mission clients which are Veterans and First Responders, spouses and minor children in the home along with Gold Star Families who have PTSI, at no cost to the mission clients. 22ZERO has served over 10,000 mission clients across the U.S. and those deployed overseas for five years. 22ZERO does not report to the V.A. or first responder agencies and only relies on donations. 22ZERO is a peer-to-peer program for those who are suffering from PTSI. The project is to serve more mission clients, as the trained peer trauma coaches do receive payment for working with mission clients. There are two components for 22ZERO, one is providing an holistic approach to those who have PTSI and training agencies (law enforcement and firefighters who have a peer program). 22ZERO would be able to serve more mission clients and provide more training at no cost to the departments if awarded the funds.

### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The project is to serve more mission clients, as the trained peer trauma coaches do receive payment for working with mission clients. There are two components for 22ZERO, one is providing an holistic approach to those who have PTSI and training agencies (law enforcement and firefighters who have a peer program). 22ZERO would be able to serve more mission clients and provide more training at no cost to the departments. Below are the specific goals for the funding.

### b. What activities and services will be provided to meet the intended purpose of these funds?

1. Provide free holistic approach to reduce PTSI and the number of suicides for mission clients, while they remain home and without them telling any of the traumatic content of the events, using a secure Telehealth platform, 100% confidentiality, and without reporting to the V.A. or first responder agencies. There would be \$100,500.00 used for paying trauma coaches to work with 1,505 mission clients.

2. Provide free training to peer support law enforcement or fire department agencies which have an established peer program. The requested \$300,000.00 would include training a total of 10 departments in Florida, with a minimum of 10 first responders per class. Training for a first responder agency is \$1995.00 per person. By training 100 first responders in Florida, the cost would be \$199,500 of the \$300,000.00.

### c. What direct services will be provided to citizens by the appropriation project?

1. Provide a free holistic approach to reduce PTSI and the number of suicides for 1,505 mission clients by using the Trauma Resiliency Protocol and The Emotions Management Process.

2. Provide a peer to peer training for 10 first responder agencies, with 10 first responders, at a total of 100 first responders trained in the Trauma Resiliency Protocol.

### d. Who is the target population served by this project? How many individuals are expected to be served?

Veterans and First Responders, spouses and minor children in the home along with Gold Star Families - 1,505 mission clients with PTSI to connected with a trained trauma peer coach. 100 first responders (Law Enforcement and Fire Department Agencies with a peer program)

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected benefit will have served 1,505 mission clients who have PTSI or suicidal using a peer-to-peer program. The other benefit would have 100 first responders trained in the peer-to-peer model using the Trauma Resiliency Protocol and the Emotions Management Process. The methodology will include all mission clients and agencies trained complete a pre and post assessment after completing the process. The pre and post assessment includes a trauma screen, depression screen and anxiety screen. A copy of the pre and post scores can be submitted after completing the request to show the pre and post scores of those served.

### f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

### for failing to meet deliverables or performance measures provided for the contract?

22ZERO would assure all 1,505 mission clients are connected with a coach and go through the process. The only barrier could be the mission client not completing the program which would be documented. The 10 first responder (Law Enforcement and Fire Department Peer Agencies) would be scheduled for the 2-day, 8-hour training. The barrier could be if one of the first responders does not attend both days of training, but we would do a make-up session with them if that did occur.
