The project will extend a sanitary sewer force main along Congress Avenue to serve commercial properties, currently operating on septic tanks.

The project area includes 84 parcels without public wastewater service. The area is comprised of both Village and unincorporated properties; therefore, this is a joint project as Palm Springs and Palm Beach County partner to facilitate and economic growth along the commercial corridor through installation of public utilities.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The goal is to provide commercial properties along Congress Avenue, currently being served by septic tanks, with a sanitary sewer force main and supporting lift stations.

The project area includes 84 parcels without public wastewater service. The area is comprised of Village and unincorporated properties; therefore, this is a joint project as Palm Springs and Palm Beach County partner to facilitate and economic growth along the commercial corridor through installation of public utilities.

b. What activities and services will be provided to meet the intended purpose of these funds?

Installation of 4-inch and 6-inch force mains. Flow will be directed to existing lift stations and gravity lines to the east and west of the project area, and the system will flow to the existing 42-inch force main to the north. New pumps and valves are necessary to maintain adequate pressures and flows through the system. The new utilities will be installed within road rights-of-way.

c. What direct services will be provided to citizens by the appropriation project?

Replace private septic tanks serving urban commercial properties with public wastewater service operated by Palm Beach County Water Utilities Department. The project will eliminate 87 separate septic tanks with the installation of 9100 linear feet of 4-inch wastewater force main and 2800 linear feet of 6-inch wastewater force main.

d. Who is the target population served by this project? How many individuals are expected to be served?

The project serves primarily the commercial corridor along Congress Avenue, and portions of Forest Hill Boulevard. There are 26 residential properties within the project area (24 single family homes and 2 rental properties with 11 apartments), with an estimated population of 82 residents.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The primary benefit is the provision of public wastewater service along an urban commercial corridor, located within Palm Springs' Community Redevelopment Area, to facilitate redevelopment, attraction of new and expansion of existing businesses. Outcomes may be demonstrated through number of new jobs created, and/or dollars spent on redevelopment/renovation of properties connected to the new sewer force main.
