4. Project/Program Description

The Florida Department of Environmental Protection has determined that water quality in Lake Bumby is impaired for total phosphorus (TP) nutrient and has placed the lake on its list of impaired surface waters. This proposed water quality improvement project is a whole-lake treatment using buffered alum proven to remove TP from the water column and sequester TP released from benthic sediments. The project proposes to treat both lakes Bumby and Tyner which are located in a highly urbanized area. The project is located within the Lake Okeechobee Basin Management Action Plan (BMAP) area, which requires reduction of total phosphorus.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The project is a water quality improvement that will remove phosphorus nutrients within the water column and inactivate nutrients in the unconsolidated (muck) sediments in lakes Bumby and Tyner. The project is located within the Lake Okeechobee Basin Management Action Plan (BMAP) area, which mandates reduction of total phosphorus by BMAP stakeholders.

b. What activities and services will be provided to meet the intended purpose of these funds?

Pre- and post-treatment sediment and lake monitoring will provide data. Treatments will remove phosphorus from the water column by flocculation and settling and will sequester nutrients within the sediments so that they are no longer available for use by algae. This will help prevent potential algal blooms and production of algal toxins.

c. What direct services will be provided to citizens by the appropriation project?

This project will improve water quality for the citizens of and visitors to Orange County.

d. Who is the target population served by this project? How many individuals are expected to be served?

The citizens of and visitors to Orange County. 2020 census indicated Orange County population is 1,429,908.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project is expected to reduce nutrients within Lakes Bumby and Tyner and the Lake Okeechobee BMAP area. Lake surface water and sediment sampling will measure reductions of nutrients.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Failure to utilize the funds in the specified manor shall result in funds being returned to the State.
