c. What direct services will be provided to citizens by the appropriation project?

Direct services provided as a result of this project are water services along with roadway improvements which will be done once water improvements are complete.

d. Who is the target population served by this project? How many individuals are expected to be served?

The entire population of Jackson County (48,599), will be served, in that this project is located in and serves Community Redevelopment Area. Additionally area serves a blighted area where over 50% of families are Low to Moderate Income. It should also be noted Jackson County, the City of Marianna has been designated by the Governor as a Rural Area of Opportunity, (RAO) formally Rural Area of Critical Economic Concern (RACEC).

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected outcome is to have an infrastructure system that meets all Federal, State and Local Code requirements for health and safety concerns. The primary way of measuring performance is to have the City's Water and Waste Water Divisions provide monthly water loss reports The project will also provide measured improvements to the infrastructure within the RAO designated community allowing for additional water and waste water capacity in our downtown business district.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The contracting agency, City of Marianna will establish a Critical Path with date specific targets for pre-development. Once bids are received and warded for the project, the contract will have specific contract completion dates, if not met contractor will be subject to Liquidated Damages, assessed on a daily basis.
