The Town of Grand Ridge requests debt forgiveness for an existing loan that was used to build the town's wastewater treatment system. Following Hurricane Michael in 2018, the town spent thousands of dollars on repairs to serve its citizens, and during COVID, the town once again experienced financial hardships that they are working diligently to overcome. The forgiveness of the remaining loan would enable the town to make the needed repairs, which are slated to cost considerably more now because of the increase of costs in parts and labor.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The Town of Grand Ridge is requesting debt forgiveness to pay the remaining principal of an interest bearing loan with DEP that was used to build the town's original wastewater treatment center. The cost of repairs needed on the system have increased dramatically because of the rise in cost of goods and services. Debt forgiveness would enable the town to make the repairs and avoid raising utility rates for the citizens during the current economy. The Town of Grand Ridge (GR) is a small rural community a with a population of 800 and Median Household Income of \$32,375 per 2020 census. Grand Ridge is located within the Fiscally Constrained County of Jackson as defined by Florida Statutes and is part of a Rural Area of Opportunity formerly Rural Area of Critical Economic Concern.

b. What activities and services will be provided to meet the intended purpose of these funds?

The wastewater treatment plant is over ten years old and will soon need major repairs. Maintaining the water treatment system to protect the health and welfare of the residents and to protect the many springs located throughout Jackson County is a top priority. Because of the downturn in the economy, the town's escrow account did not perform as expected for several years resulting in a loss and will be depleted in 2024.

c. What direct services will be provided to citizens by the appropriation project?

The Town of Grand Ridge will be able to provide wastewater services to its residents without rates, which would create a financial hardship on the families of the community.

d. Who is the target population served by this project? How many individuals are expected to be served?

The residents of Grand Ridge and Jackson County along with tourists and evacuees that will use Interstate 10, Highway 69, and Highway 90. 2020 Census - 800 population; tourists, evacuees, indeterminate number.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The funds will be used to offset debt incurred and allow the Town to maintain their current utility rates, which provides more money in the pockets of the residents and tourists. The funds saved from future payments will fund the increase of the cost of repairs and maintenance that have been impacted by inflation.
