Planning, engineering, design and construction of a public land side boardwalk and observation pier underneath the Marler Bridge along with multimodal facilities from the Zerbe Street and Calhoun Avenue intersection, south along the west right-of-way of Calhoun Avenue, west along Harbor Boulevard (US 98), and south under the Marler Bridge to the existing harbor boardwalk. The purpose of the project is to provide a pedestrian connection between the north and south sides of Harbor Boulevard to maximize pedestrian access to the south side of the harbor, provide public space, and offer a scenic viewing area.

The funds will resolve significant pedestrian traffic and safety issues in a heavily developed area of Destin, directly adjacent to the Marler Bridge. In the project area, thousands of pedestrians currently intersect with the significant traffic stream on U.S. 98 (40,000 vehicles per day). This project will severely reduce or remove these vehicle-pedestrian interactions. The project will substantially improve public safety and will remove one of the sources of regional congestion on U.S. 98. The project will also enhance commercial activity on Destin Harbor and Choctawhatchee Bay.

b. What activities and services will be provided to meet the intended purpose of these funds?

The planning, permitting, design and construction of a full recreational pedestrian underpass.

c. What direct services will be provided to citizens by the appropriation project?

Enhanced public safety, recreation, and improved commercial activity and access.

d. Who is the target population served by this project? How many individuals are expected to be served?

Because the project is at the Marler Bridge, the project impact is regional. Removing the significant pedestrian traffic stream from US 98 will have a positive effect on congestion in the area. For residents both inside and outside of the City of Destin, the improvements under this request will enhance the visitor experience along Destin Harbor and Choctawhatchee Bay.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Project success will include the removal of thousands of pedestrian crossings from the US 98 traffic stream.
