Funds are requested to begin project planning and completing permitting and design work for a pedestrian footbridge to cross the Yellow River in Okaloosa County to close a major gap of the Florida National Scenic Trail in Okaloosa County connecting the FNST section in Eglin Air Force Base to conservation lands managed by NWFWMD. This infrastructure is the missing link that will make possible a major re-route of the FNST from road walks onto footpaths on public land.

A successful outcome for this stage will include a site survey, bridge design, acquisition of all necessary permits, and compliance with all necessary cultural, historic, and environmental review processes. Okaloosa County, in partnership with the Florida Trail Association and USFS, will pursue local funding and grants to complete construction of the bridge and remaining trail gap.

b. What activities and services will be provided to meet the intended purpose of these funds?

Okaloosa County will contract with a professional engineering firm to complete site surveys, bridge design, acquisition of necessary permits, cultural/historical/environmental surveys and reviews and development of construction plans and specifications. The bridge will be designed consistent with the FNST Comprehensive Plan and FNST Strategic Plan.

c. What direct services will be provided to citizens by the appropriation project?

Once the bridge and trail gap construction is complete, the provision of additional FNST routes will be available to citizens.

d. Who is the target population served by this project? How many individuals are expected to be served?

Our target population is primarily local recreational trail users from the communities of Crestview, Niceville, and Fort Walton Beach, as well as tourists from throughout Florida and beyond. The Florida National Scenic Trail also attracts a growing annual number of thru-hikers, visitors who intend to hike the entire length of the 1,500 mile trail, and who will benefit from a safe and protected route through this region. While we don't have trail counter data for this specific site, a location elsewhere in the Panhandle reported 4,557 annual users.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected outcome is to have construction ready plans and specifications to bid out the construction of the bridge.
