4. Project/Program Description

Community Health Centers of Pinellas, operating under the name Evara Health, is putting forward a capital project aimed at expanding healthcare access for vulnerable populations and offering professional and employment opportunities to Pinellas County residents for the long term. This project entails the establishment of a 16,000 square-foot medical, dental, and behavioral health facility in the Countryside area. The facility is currently unoccupied, and a Lease Letter of Intent (LOI) has already been executed.

The renovation plan includes a redesign of the interior layout to accommodate 21 medical examination rooms, along with a dental clinic and a pharmacy with ample space to provide services and facilitate the training of auxiliary dental, medical, behavioral health, and pharmacy staff. Upon reaching full operational capacity, the center will serve approximately 7,600 residents, conducting over 20,000 visits annually, including 2,200 behavioral/mental health services

\$500K for alterations of the current health service sites. The assistance was provided on a one-
time basis.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Evara Health proposes to establish a new primary care medical health center and health care professional training facility in Countryside area of Clearwater, Pinellas County, Florida. The new building will become a medical/behavioral health/dental facility outfitted for both providing patient care and training of ancillary dental, medical, and pharmacy staff. At full operational capacity, the center will be be serving 7,600 patients, providing over 20,000 visits, including 2,200 visits for behavioral/mental health services. The new facility will also provide the opportunity for members of the community to obtain a well-paid profession that is in high-demand in medical field and for the medical institutions throughout the Pinellas County to gain a new reliable source of the qualified workforce.

b. What activities and services will be provided to meet the intended purpose of these funds?

The project will renovate 16,000 SF of currently vacant building to medical/dental facility at the Countryside area of Clearwater. Renovation activities will include redesign of the interior floor plan to create 21 medical examination rooms, provide a suitable waiting area, ensure proper patient flow and improved access to the ancillary areas, as well as dental clinic and pharmacy spacious enough to provide services and host training of ancillary dental, medical and pharmacy staff.

c. What direct services will be provided to citizens by the appropriation project?

Once renovated, the facility will render medical, dental, behavioral/mental health, pharmacy, eligibility assistance, chiropractic, and case management support, services to residents of Pinellas County. The site will also host training of future dental/medical assistants, pharmacy technicians, and behavioral health ancillary staff, upskilling Evara staff and providing educational opportunities to those in the surrounding communities.

d. Who is the target population served by this project? How many individuals are expected to be served?

The project's target population are low-income, uninsured and under-insured residents of Pinellas.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The project will improve access to the quality affordable health care services for residents of Central Pinellas County. Evara Health seeks to increase its capacity to serve the vulnerable populations of the County. At full operational capacity, the center will be be serving 7,600 residents for over 20,000 visits on annual basis, including 2,200 visits for behavioral/mental health services. Evara Health will monitor all program outcomes, including a number of patients served, type and volume of provided services and clinical outcomes with the help of Nationally Certified Electronic Health Records system and following the standards of Uniform Data System reporting.
