request for funding for repair and replacement of 143 manholes. The City of Fort Meade has 117 year old aging sewer infrastructure needing replacement. We have assessed 143 manholes needing repair and replacement. Much of the mortar in the manholes has eroded and will create collapsing and failing infrastructure that needs to be mitigated as soon as possible. Groundwater infiltration overloads the plant during major storm events that could cause a failure impacting the Peace River that runs next to the WWTP. All manholes have been GPS'd and tagged.
