Our Children Have Rights serves children by assisting parents navigating their child custody and co-parenting processes, at no cost to the family. We provide:

No-cost consultations: Direct engagements with parents are performed via Zoom, FaceTime, Phone, Email & Text. Services are accessible to all parents, statewide, across 67 counties. Consultations are on an as needed, on-going basis. No-cost document review: Focusing on parenting plans & related documents.

No-cost virtual resource center: Education, legal aid navigation support, and mental health and wellness.

a. What specific purpose or goal will be achieved by the funds requested?

Protect the rights of children to have access to their parents by providing education, resources, and support services for successful co-parenting strategies. To create a seamless process for parents while establishing custody of a child and provide the opportunity for the child to reach their full potential.

b. What activities and services will be provided to meet the intended purpose of these funds?

No-cost consultations. No-cost document review. No-cost parenting workshops.

c. What direct services will be provided to citizens by the appropriation project?

No-cost consultations: Direct Engagements with Parents via Zoom, FaceTime, Phone, Email & Text No-cost document review: For Parenting Plans & Related Documents No-cost parenting workshops: In conjunction with community-based organizations, Children's Services Councils, and other nonprofit organizations.

d. Who is the target population served by this project? How many individuals are expected to be served?

At-risk youth, persons with poor mental health, jobless persons, economically disadvantaged persons, homeless, drug users (in health services), preschool students, grade school students, high school students, university/college students, currently or formerly incarcerated persons, drug offenders (in criminal justice).

Over 800 individuals expected to be served via no-cost consultations & documentation review.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Protect the general public from harm (criminal etc.): Children of the parents served will be less likely to engage in violent behavior, abuse chemical substances, and drop out of school. Parents who maintain legal access to their children will be more likely to live responsible lives & law-abiding citizens.

Parents who maintain legal access to their children will be more likely to live responsible lives & law-abiding citizens. Enhance specific individual's economic self sufficiency: Help custodial parents establish/receive child support to minimize reliance on additional welfare programs.

Reduce Recidivism: Involved parents reduces recidivism.

Divert from Criminal/Juvenile Justice System: Providing critical services to parents to maintain legal access to their child(ren) prevents kids from moving entering the system in the first place.

Other: Increase public safety for Floridians, ensure parents egal access to their child(ren), lessen the need for parents to rely on public benefits, saving taxpayer dollars. Increase state revenues from federal government for administering child support payments.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Suggested penalties to be considered include a repayment of a portion of the funds, proportionate to the shortfall in deliverables. Receipts of all funds spent on professional services and other deliverables can be produced.
