#### 4. Project/Program Description

This project will install 3,449 feet of living shoreline and restore historic oyster reef habitat in McKay Bay while providing co-benefits of wave attenuation and reduced erosion to the Palmetto Beach Community. The project area is identified and supported by multiple science-based studies and organizations, including the National Fish and Wildlife Foundation and Florida Fish and Wildlife Commission Tampa Bay Living Shoreline Suitability Model. This project will bring much needed investment to a historic waterfront crabbing and fishing community vulnerable to recurring flooding, storm surge, surface water run-off, and restore a connection to the working waterfront. The primary issue these improvements will address include vulnerabilities of storm surge and sea level rise, and providing safe, sustainable water connections to a once vibrant community that has become disconnected and isolated due to decades of surrounding industrial development and underinvestment.
