This project seeks to improve living conditions and lower annual costs of shelter operations, increase security and update technological needs for the only women and children's emergency shelter in Hardee County. This includes the replacement of weathered windows and doors for energy efficiency and added security, installation of a Solar energy system to lower energy costs, purchase of computers with running capacity to operate on Windows 12 (current computers lack ample capacity), technologically updated security cameras, household appliances, and a fire console for county fire code compliance. Funding is also requested to ensure onsite night management for shelter operations and to meet the rising costs of insuring shelter property and building.

a. What specific purpose or goal will be achieved by the funds requested?



Goals are improved living conditions and lower annual costs of shelter operations of the only women and children's emergency shelter in Hardee County. Replacement of weathered windows and doors for energy efficiency and security. Installation of a Solar energy system to lower energy costs. Purchase of 15 computers with running capacity to operate Windows 12 software (current computers do not have ample capacity), updated security cameras, household appliances, and fire console for county fire code compliance.

b. What activities and services will be provided to meet the intended purpose of these funds?

Ensure fire safety regulations per county fire code, ensuring the safety of client's and their dependents. Activitities via computer communications with area schools and medical agencies, appointment setting with social service providers, research and obtainment of essential documents, employment search and training, online employment and higher educational attainment. properly functioning household appliances for life skills training and the meeting daily needs. reinforecment of windows and doors for security purposes.

c. What direct services will be provided to citizens by the appropriation project?

Onsite shelter manager to care for client's on a nightly basis. Case management, counseling, parenting classes, anger management/D/V classes, financial budgeting and planning, life skills training, online employment, legal assistance, shelter/housing, nutritional education and practise, access to medical and mental health online services, GED, ESOL, and higher educational services, twenty four hour onsite security and uninterrupted utilities. Onsite night manager for security and shelter operations.

d. Who is the target population served by this project? How many individuals are expected to be served?

Elderly women, persons with poor mental health, persons with poor physical health, jobless persons, and economically disadvantaged persons. At-risk youth, homeless, physically disabled, formerly incarcerated persons, and victims of crime. We serve 50-100 persons monthly.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Adequate computer technology interaction with Windows 12 software having the capacity to be compatabile with online servers and entities will ensure seamless educational and employment experiences. Methodologies are tracking gainful and steady employment of client's, teachers progress notes and counselor evaluations, employer recognition and successful training certifications, Educational Criteria of students achieving benchmarks and grade metrics successfully. Increased security and lower utility expenses due to window and door replacements and installation of Solar System and updated security cameras. Outcomes will be evidenced via lower monthly energy costs, ability to give concise evidence to law enforcement and courts with clear video of events, and reinforcement of structural integrity of shelter.
