4. Project/Program Description

The Hookers Point Community is primarily a residential community located in eastern Hendry County south of Lake Okeechobee and east of the City of Clewiston. This project serves to expand wastewater service and eliminate onsite sewage treatment and disposal systems and to convert to central sewer facilities. This project is included in the Florida Department of Environmental Protection's (FDEP) Basin Management Action Plan (BMAP) Area of Lake Okeechobee and in the Eastern Caloosahatchee River Basin of the Caloosahatchee River and Estuary Basin BMAP. This project is an important part of Hendry County's efforts to reduce nutrients coming from wastewater within the BMAP area. This project will allow the County to move forward with septic to central sewer conversions in the Hookers Point Community. The project will include a wastewater force main pumping system which will serve as the backbone for the septic to sewer conversion project.
