#### 4. Project/Program Description

During significant rain events, areas of U.S. 192, a state hurricane evacuation route, flood and cause road closures and property damage. Our stormwater master plan identified critical areas in need of improvement. These areas also are in our Community Redevelopment Area (CRA) and are in an area identified by HUD as a Low Mod area. The proposed improvements – including installation of new drainage inlets and high capacity storm sewer pipes – will improve the capacity of the aging stormwater system in that area, preventing road closures and property damage.
