4. Project/Program Description

A Mobile Response Team (MRT) providing 24/7 emergency behavioral health care specific to Collier County. The team will meet anyone having a severe emotional or behavioral health crisis in their home, school, or wherever they are. The goals of MRT are to reduce trauma, prevent unnecessary psychiatric hospitalizations and criminal justice involvement through deescalation, appropriate crisis intervention, and connecting people to resources in their communities. The MRT will provide immediate, on-site behavioral health crisis services to individuals who have an emotional disturbance; or are experiencing a mental health or emotional crisis; or are experiencing escalating emotional or behavioral health reactions and symptoms that impact their ability to function typically within their family, living situation, or community environment; or are served by the child welfare system and are experiencing or at high risk of placement instability.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The goals of MRTs are to reduce trauma, prevent unnecessary psychiatric hospitalizations and criminal justice involvement through de-escalation, appropriate crisis intervention, and connecting people to resources in their communities. This funding will create an MRT dedicated solely to Collier County, ensuring 60 minute response time within the county. The additional team will improve care both within Collier County and in the four other counties that make up the 20th judicial circuit.

b. What activities and services will be provided to meet the intended purpose of these funds?

Mobile Response Teams (MRTs) provide 24/7 emergency behavioral health care. MRTs provide immediate, on-site crisis services to individuals who have an emotional disturbance; or a mental health or emotional crisis; or emotional or behavioral health reactions and symptoms that impact their ability to function typically within their family, living situation, or community environment.

c. What direct services will be provided to citizens by the appropriation project?

MRTs provide in person and telehealth services to provide on demand crisis interventions in any setting in which a behavioral health crisis occurs. Services include screening and assessment, crisis de-escalation and stabilization, crisis counseling, development of safety or crisis plans, psychoeducation, and care coordination.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes any Collier County resident who is in a mental health crisis. MRT services can be accessed by citizens directly or in coordination with law enforcement, emergency medical technicians, or other first responders. The MRT is expected to serve at least 800 citizens annually.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected benefits of a Mobile Response Team dedicated exclusively to Collier includes improved health outcomes for individuals in a mental health crisis, improved coordination with the Collier County Sheriff's Office Mental Health Intervention Team, assurance of a less than 60 minute response time to mental health crises occurring in the community, and an increase in the number of diversions from involuntary commitments to behavioral health treatment under Chapter 394 F.S. or arrest.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Penalties for failing to meet deliverables or performance measures will be developed in collaboration wit the Department of Children and Families and the Central Florida Behavioral Health Network during contract negotiations.
