4. Project/Program Description

Port LaBelle is one of the fastest growing areas in Hendry County with 310 homes being built in 2022, 187 homes built in 2023 as of August 1, and 650 homes having active permits and applications. From 2017-2021 there was a 68% increase in the number of potable water service connections. The Port LaBelle Utility System potable water treatment plant is in need of expansion to provide additional plant capacity in order to continue to accommodate the rapid increase in residential connections. This area is included in the Florida Department of Environmental Protection's Basin Management Action Plan (BMAP) area in the Eastern Caloosahatchee Basin. This project would provide economic improvements for Hendry and Glades Counties. Staff submitted a grant application to DEP in July for the total cost of the project, however, DEP has not yet announced the awarded projects.
