4. Project/Program Description

Resilience360 (R360) is a veteran-founded, three-part solution that reduces taxpayer expense in NW Florida's Criminal Justice system by serving the two most critical components within Criminal Justice: law enforcement officers/first responders (LEO/FRs) and inmates with:

1. Mission-Based Resilience (MBR), a multi-day course in a classroom group setting on agency grounds that instructs LEO/FRs in U.S Navy SEAL success principles and Cognitive Psychology tenets to proactively reduce or avoid the Post Traumatic Stress Disorder (PTSD) that harms personnel and costs organizations.

Resilience Inmate Program (RIP), a month-long course in a classroom group setting onsite at jail facilities that instructs inmates in U.S. Navy SEAL success principles and Cognitive Psychology tenets to reduce recidivism.
Resilience Integration Program Promoting Lifelong Success (RIPPLS), an ongoing, weekly one-on-one coaching

program to reinforce R360 curriculum to LEO/FRs and inmates in real-time.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The goal is to increase Bay County's \$11 million in taxpayer savings already generated by graduating 846 Bay County LEO/FRs and Bay County inmates from Resilience360 curriculum courses and coaching. We'll do so by: 1. Continuing classroom instruction of Mission-Based Resilience (MBR) + post-course coaching (RIPPLS) for Bay County (LEO/FRs) in order to help them proactively avoid PTSD.

2. Continuing classroom instruction of the Resilience Inmate Program (RIP) + post-course coaching (RIPPLS) for Bay County inmates in order to reduce recidivism.

b. What activities and services will be provided to meet the intended purpose of these funds?

R360's curriculum will be taught based on U.S. Navy SEAL success principles and Cognitive Psychology: 1. to LEO/FRs in order to proactively avoid PTSD that debilitates individuals and organizations; and 2. to inmates in order to reduce recidivism and lessen taxpayer costs; then post-instruction, 3. to provide both client groups ongoing, weekly one-on-one coaching to habituate learning.

c. What direct services will be provided to citizens by the appropriation project?

RIP: minimum of six classroom courses/yr; 20 students; 100 hrs total (80% in-class instruction/20% physical teamwork activity) two instructors min. onsite at correctional facility. MBR: minimum of six classroom courses/yr; 20 students; 20 hrs total (90% in-class instruction/10% physical teamwork activity) two instructors min. onsite at agency facility. RIPPLS: ongoing, weekly one-on-one coaching.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population of R360 is the two most important components in the Criminal Justice system in Bay and surrounding counties: 1(a) law enforcement/first responders - LEO/FRs - and 1(b) inmates both male and female. Since respective K360 program launches in 2010 (MBR), 2017 (RIP), and 2023 (RIPPLS), we have served these citizens and will continue to do so. Expected individuals to be served is in excess of 800 per year.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

MBR and RIPPLS benefits LEO/FRs by improving employee retention, workplace engagement and mental health.for those in crisis incident jobs. \$100,000-\$240,000 is the average replacement cost for one LEO/FR. (FL Public Pension Trustee Assoc.), 55% pf LEO/FRs consider quitting weekly.(Police1 2020 Study). MBR and RIPPLS exist to combat this. Measurement occurs through course survey feedback, repeat engagement, and limited personnel updates. RIP and RIPPLS offers the benefit of recidivism reduction. \$151,662 is the cost of one recidivism event (Pew Charitable Trust). 60% of RIP's 286 graduates from 2017-2021 in Bay County didn't relapse, compared to 32% nationwide. Compared, RIP's 60% is 2X better than the nation's 32%, equaling \$11,071,326 in savings in Bay County and NW Florida. RIP and RIPPLS exist to drive such outcomes, and measures facility/coaching demand, course frequency, enrollee growth, graduation rate, recidivism rate nationwide, and taxpayer savings.

Such processes are presently in place and will continue.
