#### 4. Project/Program Description

Happy Brew Vocational Program and Enrichment Venue meets a crucial community need for a universally-designed outdoor center where individuals with intellectual and/or developmental disabilities (IDD) can access work readiness training, occupational therapy, employment, and life-enriching activities. Happy Brew's vocational program and venue originated from a five-year study process out of Flagler College. Happy Brew's vocational programs are fully operational and serve as a hub for the IDD community. Funding for an outdoor venue will provide expanded capacity for work readiness and life enrichment opportunities for individuals with unique abilities, and serve as a place of inclusion for the community at large. Situated within a strategic 2-mile radius from downtown Jacksonville and three major interstate exits, the location ensures unmatched accessibility.

#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The specific purpose to be achieved by the funds requested is to deliver a new innovative service-delivery model for individuals with intellectual or developmental differences where we can expand our occupational therapy program and immerse individuals with IDD in community life via this outdoor center. Participants will gain on the job experiences and skills needed to obtain competitive employment while involving the community, allowing more to get involved thus providing more opportunities for adults with IDD to live fulfilled lives.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The project will use research-based, occupational therapy-driven practices to increase work readiness for individuals with intellectual and/or developmental disabilities (IDD) through vocational training and paid employment. Additionally, a universally-designed outdoor venue will serve as a hub for community partnerships and proven effective approaches for life-enrichment, community inclusion, and caregiver networking to improve quality of life for those with IDD while preventing social isolation.

#### c. What direct services will be provided to citizens by the appropriation project?

citizens will receive evidence-based vocational and self-advocacy training, work readiness, on-the-job support, lifeenrichment activities, caregiver support, community inclusion events, and linkages to other disability service organizations.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Happy Brew's Vocational Program and Enrichment Venue will target individuals with intellectual and developmental disabilities, ages 16+, and their caregivers. It is anticipated that annually: a) 24 individuals with IDD will participate in the 12 week internship program, b) 15 individuals with IDD will receive competitive-wage employment and on-the-job-support, and c) 100 individuals with IDD will participate in community enrichment programs.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit of the project is that individuals with IDD would achieve a greater quality of life by increasing a) self-sufficiency and independence through the vocational and employment services, and b) engagement in lifeenrichment activities that reduce social isolation and promote positive mental health. Methodology for outcome measurements include: a) Pre and post tests for vocational training participants, b) job skills acquisition for employees, c) life-enrichment activity satisfaction, d) number of participants, e) number and types of community partnerships (disability service linkages/referrals, volunteer groups, etc.).
