14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The goal of the Holocaust Memorial, Museum and Education Center in Palm Beach County is to provide educational services, to our communities, about Holocaust history and examine human behavior and attitudes that led up to and condoned the Holocaust, so that we may educate our community to be rsponsible and respectful and encourage tolerance in our multicultural society, to fight antisemitism and racism

b. What activities and services will be provided to meet the intended purpose of these funds?

The Holocaust Memorial and Museum will greatly enrich the Jewish Communal experience in West Palm Beach by providing an educational resource about The Shoah, which will serve to educate the community about the pitfalls of continued antisemitism. Educational services will be provided by all trained and vetted museum staff.

c. What direct services will be provided to citizens by the appropriation project?

The direct service provided will be education for all age groups. The monument and museum will provide a center for cultural education and experience that can be shared with the diversity that is Palm Beach. Visitors will have direct access to artifacts, curriculums, memorials and first person testimony. Traveling exhibits will be available to schools and communities.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is all members of the Palm Beach County community, seasonal visitors and tourists, Palm Beach County schools, colleges, including men, women, and children of all ages. The memorial and museum will serve individuals of all faiths, ethnicities, or socioeconomic standings. Tens of Thousands of residents of Palm Beach and neighboring counties will be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Culturally, the Holocaust memorial, museum and education center will provide unique programs for our Jewish community to learn about their history and cultural heritage of resilience in the face of horrific tragedy, provide our non jewish community with an understanding of the diverse Jewish culture, provide cultural exchanges to build a stronger community where hate has no place. The Holocaust memorial, museum and education center will provide an important educational resource and fellowship, for the community, our teachers and our students. The county schools will have a resource center that will assist them in meeting or exceeding the Florida mandate on Holocaust education. Education is the best tool to combat ignorance and hate. The museum and education center will measure the level of benefit and outcome through tracking of visitors, to the memorial and museum, as well as, developing and administering a voluntary survey that measures the visitors attitude and knowledge pre and pos
