This facility will be owned by the City of St. Petersburg and shared between the St. Petersburg Police Department and the St. Petersburg Fire Department. The mixed-use project will allow training for both agencies, as well as most other police and fire agencies in the southern portion of Pinellas County. It will be asset for smaller agencies, such as Gulfport, South Pasadena, Kenneth City, Pinellas Park, and several beach communities to utilize for public safety.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

These funds will be used for the design and pre-construction services needed to replace the existing Fire Rescue Training and Police K-9 compound.

b. What activities and services will be provided to meet the intended purpose of these funds?

The site is located in an area which will require significant flood mitigation. It will also require multiple city services to swap land to ensure the needs of both public safety areas have enough space to ensure adequate training areas. The intent is also to review possibly having some of the land revert back to parkland for community use. This requires a substantial review by consultants, engineers, land surveyors, and other entities to ensure the project is built at the most adequate location.

c. What direct services will be provided to citizens by the appropriation project?

At this time there will not be direct services provided to the citizens by this project. Although, the likely possibility of reverting some of the areas back to community owned park land for all citizens to enjoy.

d. Who is the target population served by this project? How many individuals are expected to be served?

This project will provide training for both the St. Petersburg Police Department K-9 Unit and the St. Petersburg Fire Department to serve the more than 250,000 residents of St. Petersburg, Florida to the best of their ability. There are currently 602 sworn officers that will use this area of some type of training. The Fire Department has over 345 personnel that will use this facility. It will also be utilized by all agencies in the southern tier of Pinellas County.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project would provide for planning and designs for the construction of a 7,500 sf office and training building, which would have an entrance "lobby," large central meeting/classroom housing a minimum of 30 personnel, four private offices, one private meeting room, three combination toilet/showering unisex facilities, lockers for 20 personnel, a kitchenette with eating space, two secured storage rooms, custodial closet, delivery/intake area, and parking for 25 vehicles. As well as warehouse space, additional classroom facilities for the Fire Department, a burn building, and a training tower that would serve a a dual purpose for fire training and SWAT operations.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Reimbursement of certain applicable expenditures could be made for failing to meet the project deliverables.
