### b. What activities and services will be provided to meet the intended purpose of these funds?

The Mobile One-Stop Unit would allow CareerSource Pinellas to provide workforce development services including Job Search Assistance, Unemployment Assistance, Training funding, and general support to communities where transportation or access to internet services present a barrier to access. Will provide needed programs and services to the Tampa Bay Region in times of emergencies and/or disasters

#### c. What direct services will be provided to citizens by the appropriation project?

Job Search Services, Resume Assistance, Interviewing, Job Application support, unemployment services, labor market information, career coaching/counseling, assistance with applying for SNAP or TANF, referral to community resources.

### d. Who is the target population served by this project? How many individuals are expected to be served?

Jobless persons; economically disadvantaged persons; at-risk youth; homeless; high school students; university/college students; currently or formerly incarcerated persons; drug offenders (in criminal justice); over 800 people will be served

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Increase/improve economic activity: increase access to Job Placement services available through American Job Centers while eliminating barriers to access such as transportation or lack of reliable connectivity/technology. Number of community outreach/engagement activities Number of individuals served who received job search or resume assistance Number of individuals served who applied for reemployment support. Create specific immediate job opportunities: Increase access to employment opportunities via community based recruitment events and employer info sessions.

\$5,000 penalty per annum if the Mobile One-Stop fails to meet it's deliverable and/or performance measures for the first 10 years of operation.
