Life sustaining food/ water/supplies water will be delivered and distributed to POD's throughout rural Jefferson County. The Elderly will have a safe and cool space with food/water

post storm. The more accessible and more timely sandbag placement may keep water from penetrating structures, keeping the occupants safe from environmental hazards (water

contamination, electrocution etc. The ability of elderly/disabled citizens as well and the general population, to help protect their home/personal property/business with sandbags.

The knowledge and comfort that life sustaining items will be available, if needed, post storm from the PODs that will be stocked. Sandbags can protect contaminated water from entering.
