Significant increase in new housing and businesses in Hendry County has resulted in a 231% increase of calls for service by the Sheriff Office in the last 15 years. The housing expense in Collier and Lee County has resulted in over 1,000 new building permits between 6/2022 and 6/2023. Many of these new structures are without portable radio or cell phone coverage. Ten public schools, which are dual, purposed as disaster. Shelters along with a hospital do not have appropriate radio coverage.
